DIRECTIONS FOR USE

- Shake vigorously before use.
- Apply the spray from 8 inches from the surface.
- Squeeze on contaminated surfaces, and dirt from penetrating flow wait.
- Parts in the open air or wipe dry with a dry cloth.
- Repeat the process several times very dirty areas.

LIMITATIONS

- Use gloves when working.
- Pressurized container. Do not expose to temperatures higher than +122°F.
- Keep away from direct sunlight.
- Do not pierce or burn, even after use.
- Keep away from sources of ignition, no smoking.
- Keep out of the reach of children.
